The Institute for Education (IfE) is compiling a database of experts in different areas who would be ready to support schools and deliver professional development sessions during and/or after school hours or deliver modules as part of courses offered by IfE. Those who want to form part of this database need not be from the Education sector but can contribute with their expertise to the continuing professional development of educators. Such contributions can be done during or after school hours according to the need of the school/Institute and availability of the expert. The experts who have already applied as per Letter Circular IfE67/2017, IfE23/2018, IfE40/2018 and IfE 50/2018 already form part of the database and therefore they **DO NOT NEED** to re-apply.

Eligibility Criteria

- A minimum qualification at MQF Level 6 in the area;
- Lower MQF level qualifications and/or sector qualifications from specific entities will also be considered if the area is very specific and accredited higher qualifications in the area are very limited.

Selection criteria

Experts shall be selected by an *ad hoc* Selection Board through an assessment of the information obtained from their *Europass Curriculum Vitae*, scanned copies of original documents listed in the Eligibility Criteria section. Applicants might be asked to attend an interview and produce original documents for verification purposes. The Selection criteria shall give weight to the:

- Information in the motivation letter which needs to include:
 - Knowledge of Education policies;
 - Expression of Educational Vision.
- Qualifications (over and above the eligibility criteria);
- Experience in the area;
- Years of adult/teacher training.

The selected applicant/s will enter into a contract for service, for a maximum of two (2) years. In the event where the expert is deemed to be unsatisfactory or not up to the required standards, the Contract shall be immediately terminated and the Expert shall forfeit all remuneration due.

Remuneration

The Expert shall be paid;

- a) €22 per hour of professional development which is non-accredited;
- b) €30 per hour of professional development which is accredited at MQF Level 4 and 5;
- c) €35 per hour of professional development which is accredited at MQF Level 6 and 7.
